Unless we are notified of any changes, families returning to **FACTS (Option 3)** will automatically be re-enrolled. If you are new to FACTS, instructions will be sent to you so that you may set up the withdrawal.
3. Families awarded financial aid are expected to meet their portion of the total tuition obligation. Failure to maintain payment schedule may result in loss of consideration for further assistance. Early payment discounts will not be applied for families awarded financial aid.
4. Past Due Accounts during the 2016-2017 year will be handled in the following manner:
  - a. Any parent/guardian whose account is more than 30 days past due will be asked to meet with the principal to discuss a payment schedule agreeable to the school.
  - b. Any account more than 60 days past due may result in the student not being allowed back to class until repayment plans have been made.
5. If the financial obligation is being split between 2 responsible parties, **both must complete this form.** (Please request additional form from office if needed). Separate FACTS accounts will be required for each payer if Option 3 is chosen.
6. Refund Policy: Any person who withdraws a child from school for any reason is responsible for tuition costs according to the following plan:
  - a. One-quarter (25%) of the total tuition costs will be charged for withdrawal between July and the end of the first quarter.
  - b. Half (50%) of the total tuition costs will be charged for withdrawal before the end of the second quarter.
  - c. Three-quarters (75%) of the total tuition costs will be charged for withdrawal before the end of the third quarter.
  - d. 100% of the total tuition costs will be charged for withdrawal after the fourth quarter begins.
